## Medical Reviews - By Appointment only at 904 301 Blvd. W., Bradenton

Pursuant to the Florida Driver License Operation's Manual RE01, Tax Collector Procedures, our office is obligated to observe customers and determine if there are any driver limitations that may affect their ability to safely operate a motor vehicle.

Please understand that we are **not** stating that you are not eligible to be issued a driver license at this time. However, you are being referred to our Driver License Office at 904 301 Blvd. W., Bradenton for further evaluation. The information used to refer you was indicated on the Driver License application or observation made in the office. This information has been placed on your record and will be reviewed at the Driver License Office.

You are required to make an appointment on [taxcollector.com](http://taxcollector.com), by clicking the red appointment button. When making the appointment online please select the "Medical-Related Testing & Re-Exams Issues/Questions" option. If you have received a letter from the State, please select the appropriate option as directed in your letter. If the State requests you need both a written exam and re-exam driving skills road test, please select written exam when making the online appointment. If needed, please have a family member or friend assist you with scheduling.

To find another office that may not require appointments to process these transactions or if you are not a Manatee County resident, please visit [flhsmv.gov/locations](http://flhsmv.gov/locations) or contact the Medical Department at 850.617.3814.

Once an appointment has been scheduled, please review required items for your appointment below:

If you do not have a gold star in the upper right corner of your license, you must bring the following documents: (visit [taxcollector.com](http://taxcollector.com) for a full list of requirements):

- Original certified US birth certificate or valid US Passport (or your current immigration documents/status if not born in the US)
- 2 proofs (from different sources) of your current physical address (where you reside)
- Original Social Security card
- Original certified marriage certificate, divorce decree or court order if you have changed your name since birth to connect your current name to your birth name

If you need to take the driving skills road test, you must also bring the following:

- Properly working vehicle (review the Florida Driver Handbook for inspection requirements)
- Current registration for the vehicle you will be testing in
- Current proof of Florida insurance for the vehicle you will be testing in (out-of-state insurance only accepted with an out of state registered plate)

In all cases:

- If you are required to take both the written and re-exam driving skills road test, you must successfully pass the written exam before the re-exam driving skills road test appointment can be scheduled.
- You may be required to take a vision exam. Please bring glasses/contacts if needed for distance.
- You must bring another licensed driver who holds a valid license. In the event that you do not pass your test, your current license will be suspended. **Note:** Failure to appear for a scheduled test will result in your driving privilege being suspended.
- All applicants must complete a [Driver License Application](#), to expedite the process complete prior to your arrival at the office.
- It is highly recommended that you study the Florida Driver Handbook available at <https://www.flhsmv.gov/resources/handbooks-manuals/> before attempting any testing.
