Lifetime Hunting & Fishing License Designations on a Florida Driver License/ID Card

Do you have an FWC Lifetime Sportsman’s, Boater, Freshwater Fishing, Saltwater Fishing, or Hunting License?

If you would like to place a designation on your Florida driver license or identification card indicating so, you must schedule an appointment to visit our Driver License Office located at 904 301 Blvd. W., Bradenton, 34205. There is a minimum fee of \$6.25 due up front for all visits, including inquiry-only visits.

Not a Manatee County resident? Out-of-County residents can only be served at our Driver License Office. An appointment is required. Visit taxcollector.com to schedule an appointment. You must select the “Non-Manatee County Resident DL/ID Card Transaction” Service in order to be served.

Any person that has an FWC lifetime license may have the designation(s) added to their Florida Driver License or ID Card. The fees associated with adding the designation(s) vary depending on the transaction type:

Designations will be displayed on the back of your driver license or identification card, as pictured to the right.

You must have documentation for the specific FWC lifetime license designation(s) you wish to obtain, in your possession, upon application – electronic formats will not be accepted.

APPOINTMENTS REQUIRED SCHEDULE AT TAXCOLLECTOR.COM

All Hunting and Fishing transactions at the Driver License Office require an appointment and an application to be completed. Late arrivals and scheduling of the incorrect appointment could result in your appointment not being honored.

Save time and come in prepared for your visit. To schedule an appointment, review transaction requirements, and print a Driver License/ID Card Application, visit taxcollector.com.



REAL ID REQUIREMENTS

- Many customers being issued a driver license or ID card may need to submit Real ID documents. For a complete list of acceptable identity documents, visit flhsmv.gov/whattobring.
All Non-US Citizens and Naturalized Citizens are required to provide USCIS (INS) documentation or Naturalization Certification. Be prepared and bring all documents with you to your appointment.
Visit egov.uscis.gov/cris for USCIS (INS) application
