# MILITARY AFFIDAVIT

Check each appropriate statement:

**Florida Insurance Exemption** - I certify that I am a Florida resident in the military (*includes a dependent, non-military spouse*) currently stationed outside of Florida and I am the owner, co-owner or registrant of the vehicle referenced above. Therefore, I am entitled to show proof of out-of-state insurance when registering my vehicles in Florida.

All of the following are required to be submitted with this affidavit when claiming this exemption:

- (1) An out-of-state residential address and mailing address (*which will be shown on the registration*) for the military member or dependent spouse
- (2) Proof of current military assignment out-of-state:
  - a. For **original registrations**, a copy of the military member's military orders
  - b. For **renewals** (one of the following):
    - i. A copy of the military member's military orders
    - ii. An affidavit from the military member confirming military assignment to another state and the date of assignment (*see below*)
- (3) An affidavit stating the motor vehicle is being maintained in the military member's state of military assignment and will not be driven in Florida, except in a transient visitor status (*see below*)
- (4) Proof of out-of-state insurance must be submitted and contain all of the following:
  - Name(s) of the insured
  - Insurance company name
  - Insurance company phone number
  - Policy number
  - Policy effective date (cannot be more than 1 year ago)
  - Vehicle(s) covered

**Sales Tax Exemption** - I certify that I am a Florida resident stationed outside of Florida on military orders. I have purchased the vehicle described above in another state (not another country) and I am applying to title and register the vehicle in Florida. The vehicle will not be brought into Florida for six (6) months or longer. **I understand that if I fraudulently claim this exemption to evade the payment of sales tax, I will be liable for payment of the sales tax plus a penalty of 200% of the tax and subject to conviction of a third degree felony.** \*\* A copy of my military orders is attached. \*\*
